CERTIFICATE OF AMENDMENT TO THE INITIAL USE RESTRICTIONS OF THE VILLAGE AT FRISCO LAKES COMMUNITY ASSOCIATION, INC.

The Board of Directors (the "Board") of The Village at Frisco Lakes Community Association, Inc. (the "Association") is the entity responsible for the operation of the Association in accordance with and pursuant to that certain Declaration of Covenants, Conditions and Restrictions for The Village at Frisco Lakes, recorded on filed of record on March 27, 2006, as Instrument No. 2006-34621 in the Official Public Records of Denton County, Texas, as well as any and all supplements thereof and amendments thereto (collectively, the "Declaration"); and

WHEREAS, the Initial Use Restrictions of the Association are attached as Exhibit "C" to the Declaration (the "Initial Use Restrictions"); and

WHEREAS, Section 4.2 (a) of Article IV of the Declaration provides a mechanism by which the Board may adopt rules which modify, cancel, limit, create exceptions to, expand the Initial Use Restrictions; and

WHEREAS, the Board proposed Rules for Estate Sales, a true and correct copy of which is attached hereto as Exhibit "1" (the "Rules for Estate Sales"); and

WHEREAS, the Board has complied with all notification requirements contained in Article IV, Section 4.2 (a) (ii) of the Declaration prior to the Board taking action to approve the Rules for Estate Sales; and

WHEREAS, the Board, at a duly convened meeting held on March 26, 2015, approved the Rules for Estate Sales.

NOW, THEREFORE, KNOW ALL PEOPLE BY THESE PRESENTS that the Board has resolved, and does hereby resolve, to approve and enact the Rules for Estate Sales.

IT IS FURTHER RESOLVED that the Rules for Estate Sales shall serve to amend the Initial Use Restrictions and become a part thereof.

IT IS FURTHER RESOLVED that the term "estate sale" is removed from Section 2. (k) of the Initial Use Restriction to avoid any conflict between the Rules for Estate Sales and the Initial Use Restrictions.

IT IS FURTHER RESOLVED that in the event of any other conflict between the Rules for Estate Sales and the Initial Use Restrictions, the Rules for Estate Sales shall control.

RULES FOR ESTATE SALES

Estate sales and moving sales are prohibited, except that a one-time estate sale may be conducted after written application is submitted by the estate sale company to the Community Association office and the application has been approved. Proof of Liability and Worker's Compensation insurance coverage must be submitted with the application.

These types of sales shall be permitted only in the event a resident Owner or spouse has passed away or an Owner or spouse is required to relocate as a result of deteriorating health.

The sale must be conducted by a professional estate sale company which must agree in writing to abide by the policies pertaining to estate sales as set forth by the Association. The sale must be held entirely indoors, which includes the interior of the garage. The garage door may not be left open during the hours of the sale. Absolutely no items may be placed on the driveway or in the yard.

The sale may be held for a maximum of two and one-half (2 $\frac{1}{2}$) days only on Thursday, Friday and half a day on Saturday during the designated hours.

The sale may be held during the hours of 9:00 a.m. and 4:00 p.m. on Thursday and Friday and 9:00 a.m. to noon on Saturday, so as not to disturb neighbors or cause an unsightly disturbance anywhere on the Lot or in the Neighborhood.

Directional signs are not permitted, but one estate sale sign will be permitted on the Lot on the day(s) of the sale.

The sale may be announced in the classified ads section of ourfriscolakes.net. The ad will expire 14 days after it is initially posted. The wording of the ad must be submitted to the Association office. The Association will then post the ad in the classified ads section of the website.

Only one (1) estate sale per homeowner will be approved.

This policy may be amended or rescinded by the Board of Directors at any time.

The foregoing was approved by the Board of Directors at its meeting of March 26, 2015, following compliance with the notification requirements contained in Article IV, Section 4.2 (a) of the Declaration of Covenants, Conditions and Restrictions for Village at Frisco Lakes (the "Declaration"). In the event of a conflict between the Rules for Estate Sales contained herein and the Initial Use Restrictions attached as Exhibit C to the Declaration, the Rules for Estate Sales shall control.
